THIS AGREEMENT made this _____ day of _____, 2018, by and between the City of Berkeley Police Department and the Village of Bel-Nor Police Department.

WITNESSETH: that the City of Berkeley, Missouri and the Village of Bel-Nor, Missouri for the considerations stated herein agree as follows:

STATEMENT OF WORK: The City of Berkeley Police Department shall furnish all supervision, technical personnel, labor, materials, machinery, services materials, supplies, etc. needed to perform and complete all work required for **Prisoner Holding Services** and any and all required supplemental work for completion of the project in accordance with the Plans, Specifications, and all Contract documents.

The Village of Bel-Nor will be invoiced monthly with payment due within 15 business days through the Village's proper approval payment methods.

CONTRACT: The executed Contract documents consist of Bel-Nor Missouri Ordinance #989 and the Berkeley proposal.

Prisoner Holding Services \$35.00 per day, per prisoner
Maximum 72 hour holding

TIME FRAME:

The contract is in full force until one or both parties have given a written 60 days' notice to stop and decrease services.

ORDINANCE NO. 989

AN ORDINANCE AUTHORIZING AN AGREEMENT WITH THE CITY OF BERKELEY FOR INMATE HOUSING SERVICES AND AUTHORIZING THE MAYOR PRO TEM TO EXECUTE SAME

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BEL-NOR, MISSOURI, AS FOLLOWS:

Section 1. The Board of Aldermen hereby authorizes an agreement with the City of Berkeley for the housing of prisoners at a rate of \$35.00 per inmate per day. The contract shall reflect the terms of Berkeley's proposal, attached hereto as Exhibit 1, and shall address other issues, such as indemnification, as determined necessary by the Mayor Pro Tem in consultation with the City Attorney.

Section 2. The Mayor Pro Tem is hereby authorized to execute the contract on behalf of the City of Bel-Nor.

Section 3. This Ordinance shall be in full force and effect from and after the date of its passage and approval.

Chief Ford,

The City of Berkeley and the Berkeley Police Department are pleased to submit this proposal for Prisoner Holding Services for the Village of Bel Nor community. The City of Berkeley operates a 72 hour holding facility certified by the State of Missouri. Any sentenced prisoner or presentenced prisoner that needs to be housed more than 72 hours must be housed in another jail. Depending on the circumstances, these prisoners may be taken to the St. Louis County Jail, a certified Full Service facility staffed full time, serving as a regional jail.

Holding cells within the Berkeley Police Department Book-in Facility are designated as the authorized areas where arrestees may be held with continuous supervision. Authorized holding cells in the in the Adult Holding Facility are separated by gender with 5 cells designated for men and 3 cells designated for women. Juveniles are held in the designated juvenile holding room until processing is completed.

With the Bel Nor Police Department's willingness to continue processing their prisoners taken into custody, the City of Berkeley will supervise the prisoner and provide meals as necessary at a cost of \$35.00 per day, per prisoner.
